

## Eight Scholarships to be Awarded for the 2009 NACM National Credit Congress

The scholarships will be for \$700.00 each to the 2009 National NACM Credit Congress, to be held June 14-17, 2009 in Orlando. This is always an outstanding event. Each scholarship will be awarded to an individual whose firm is a member of NACM Business Credit Services. All applications will be prescreened by the NACM Business Credit Services Scholarship Committee, and through a voting process, will reduce the field to the final eight (8) recipients.

The Scholarship Committee has established the following eligibility requirements: A member can not win two scholarships from the Alice M. H. McGregor Memorial Scholarship Fund in the same year, and can not win a scholarship to the same event two years in a row. Also, if you have already won a scholarship from another organization for the 2009 Credit Congress, please do not apply for this scholarship.

Any recipient of an NACM Business Credit Services scholarship must submit proof of attendance of at least seventy-five percent (75%) of the educational sessions. A copy of a signed CEU form(s) must be submitted to the NACM BCS president within 30 days after the event, and we encourage you to provide a written summary of your experience. Failure to provide proof of attendance eliminates any future eligibility for NACM BCS scholarships.

If you are eligible and interested in being considered for a scholarship, please complete the application below and on the following sheet, and return it to Don Conklin, President, NACM Business Credit Services, **by February 1, 2009**. Please note that your employer also has to sign the application, which will show his/her support in this endeavor. Please contact Don Conklin if you have any questions.
